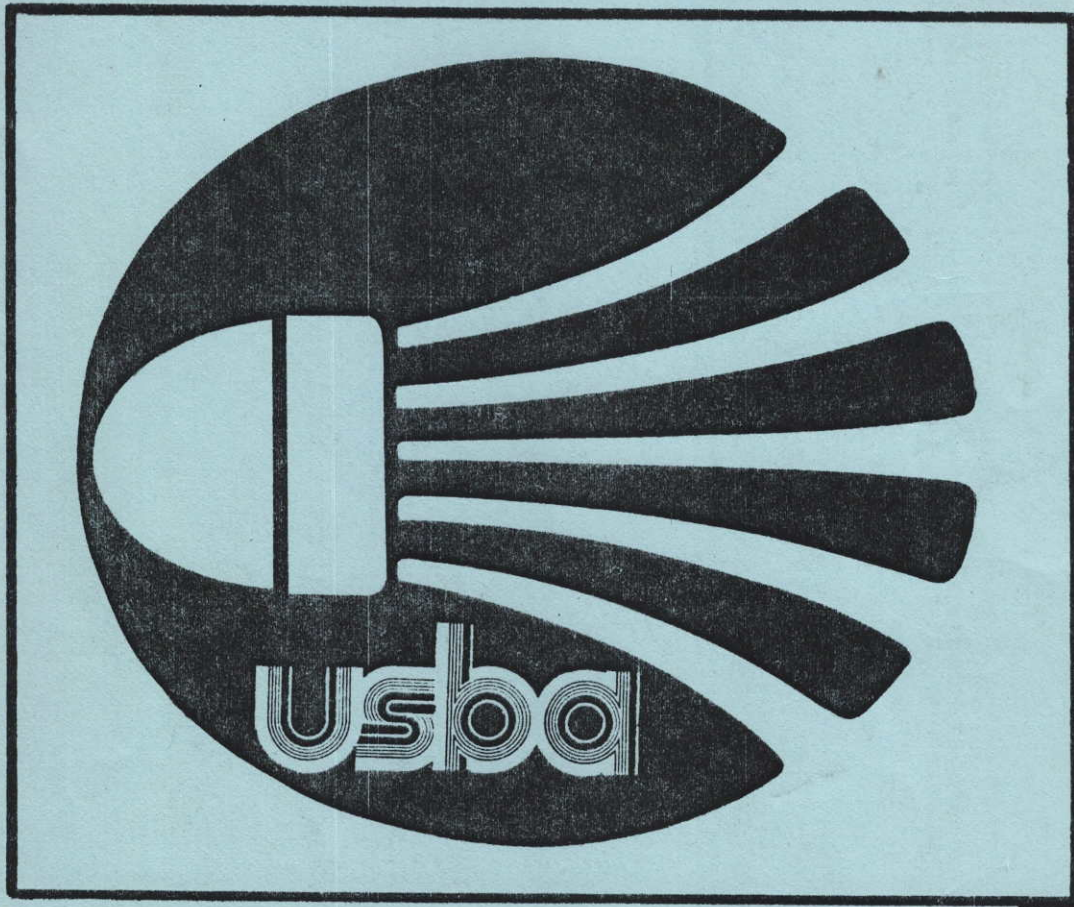

1. IN ORDER TO SATISFY THE REQUIREMENTS OF THE U.S. SENIOR OLYMPIC COMMITTEE, TWO (2) RELEASES MUST BE SIGNED PRIOR TO THE START OF THE TOURNAMENT. I KNOW SOME OF YOU HAVE SIGNED ONE OR BOTH BUT IF YOU HAVEN'T, PLEASE SEE ME AT THE DESK.
2. EVERY EFFORT WAS TAKEN TO AVOID SCHEDULING CONFLICTS. HOWEVER, IN THE EVENT THERE ARE ANY PLEASE LET ME KNOW AS SOON AS POSSIBLE. WITH THE NUMBER OF CONTESTANTS AND SEVERAL PLAYING IN MANY EVENTS, THE TIMING WAS A LITTLE DIFFICULT. I'LL APOLOGIZE IN ADVANCE FOR ANY CONFLICTS.
3. IN THE ROUND ROBIN EVENTS, THE FOLLOWING CRITERIA WILL BE USED TO DETERMINE THE WINNER, RUNNER-UP AND CONSOLATION AWARDS:
 - TOTAL MATCHES WON
 - IN THE EVENT OF A TIE, TOTAL GAMES WON/LOST
 - IN THE EVENT OF A TIE, TOTAL POINTS SCORED
4. A FEW PEOPLE WERE ENTERED (BY THE TOURNAMENT COMMITTEE) INTO EVENTS THAT THEY HADN'T ASKED FOR. THIS WAS DONE SO WE COULD HOLD THAT EVENT. IF YOU SEE YOU ARE IN AN EVENT YOU DIDN'T ASK FOR AND DO NOT WISH TO PLAY IT, PLEASE LET ME KNOW.
5. A FEW POINTS ABOUT PLAYING:
 - PLEASE REPORT YOUR SCORES TO THE DESK WHEN FINISHED.
 - IF YOU WISH LINESMAN OR UMPIRE OR SERVICE JUDGE PLEASE ASK ME.


Dear Senior Olympians:
