RULE BOOKS

We thought we would be swamped with requests for copies of the new rule book, but up to the present writing, have only received request from two Class "A" Associations. When we asked you to keep quantities to the "Absolute minimum", we didn't mean "absolute zero"!! Let's get those rule books out to member clubs as quickly as possible, so that everyone will be up to date.

FROM NEW ENGLAND

Badminton in Massachusetts is off to an early start. The season was ushered in by the University Club Mixed Doubles Tournament November 1st. When the smoke cleared after 5 torrid rounds, the Championship Flight Winners were Bob Wright (University Club) and Mrs. Wayne Schell (Poona Club) over Harold Vose and Mrs. C. Goodhue (Tedesco Country Club). Consolation: Larry Roberts and Miss Barbara Hill (Belmont B.C.) over Mr. & Mrs. Porter Atherton (Tedesco). A dinner party and dance at the Club were the finishing touches in more ways than one.

Organization for the year started with an Executive Committee Meeting and has been followed up by a Joint Committee Meeting (an annual affair which other Class "A" Associations might consider).

Program: Members of all committees gathered for a brief outline of general policy and specific projects for the year by prexy Cal. Bartlett. Followed by individual meetings by each committee where plans were made and specific responsibilities assigned. The groups then reconvened for a short general suggestion and discussion period before adjournment. Results: A unified general policy; a definite start on individual committee programs; and a general feeling of something to be done and a swell group to do it (according to all 56 committee members).

The Massachusetts Association Tournament Schedule is almost ready for the

printers. Copies will be sent to all member clubs by courtesy of the Association and provides data on twenty tournaments including the regular four (A.B.C.D.) Mass. Championships and 8 Club Tournaments (invitation) as well as important intersectional tournaments which may interest members either as contestants or spectators. Of special interest is a Conn. vs Mass. team match started last year and so much fun it is now an annual by popular acclaim. Eight ladies and eight men from each state competing in four men's doubles, four ladies' doubles and 8 mixed doubles matches for the bigger share of 16 match points.

The New Englands are scheduled for March 27, 28 and 29 (the week end before the Nationals). Rumor has it that in addition to the usual "tops" from the East and Canada there is every possibility of a real contingent from the West Coast (on their way to the Nationals). The feathers ought to fly! Johnnie Garrod is tournament chairman- address- 47 Colburn Rd. Wellesley Hills, Mass.

Activity for the younger players is due to take a spurt with the Badminton and Tennis Club sponsoring an Inter Collegiate Tournament and the State Junior Development Committee planning at least two Junior Tournaments. No dates yet.

FROM THE MID-WEST

CHICAGO

The first annual Chicago Womens
Invitational Tournament was a success from every standpoint. This
event was held Saturday and Sunday,
November 22 and 23, under the supervision of the Ogden Badminton Club.
Entries were by invitation only, and
a very representative group was
brought together. There were 30
singles entries and 17 doubles teams.
These included players from Detroit,
Akron, Warren (Ohio), Buffalo,
St. Louis, West Allis (Wis.) Racine,
etc.

The out of town competition dominated the singles event. None of the Chicago players reached the semifinals. However, the finals in the doubles event saw one full Chicago team, Eleanor Coambs and Wilma Shortz pitted against Patsy Donovan of Buffalo and her team-mate, Olga Grant of Chicago. The latter team won 15-6, 15-8.

Patsy Donovan overpowered midget Shirley Frye in the singles, 12-9, 11-4. Even in defeat, Shirley looked like a champion, and it was a beautiful match to watch.

Crowned heads were sent flying right and left. The No. 1 ranking Mid-West team of Florence Howard and Pearl Peterson of Detroit were eliminated in the quarter finals by Shirley Frye and Marguerite Wright 4-15, 15-8, 15-13, who were in turn eliminated in the semi-finals by the ultimate winners.

Wilma Shortz, Mid-West # 1 ranking singles player, was not up to her usual form, as she was eliminated in the second round by Marie Bytnar of St. Louis, 11-8, 11-4. Marie is one of those cool methodical players, who will bear watching as the season progresses. By the time the Mid-West championships roll around, she will, no doubt, give quite a few "old regulars" some anxious moments.

This entire affair was well handled and received a fine public response. The boys from Ogden are to be congratulated upon the success of their "maiden effort".

INDIANA

As a "Curtain - raiser" for the new Central and Southern Indiana Badminton Association, described in detail elsewhere in this issue, the first annual Indianapolis Invitational Tournament is being held on Saturday and Sunday, December 13 and 14. It is being held at the Indianapolis Athletic Club, where accommodations for all out-of-town players have been arranged. Players from all surrounding states have been invited, and from advance indications, there will be a huge entry list on hand to help Commander Mathews "launch" his new association.

A contingent of 40 or more are entered from Chicago alone.

The tournament will feature all events for men and women as well as mixed.

OHIO

The Ohio State Championships were held at Akron, Saturday and Sunday, December 6 and 7. While the entry list was a little smaller than usual, the play was spirited and every match was a hard-fought one.

Ken Quigley defeated Russell Grant, former Pittsburgh champion, to retain his singles crown. Ken teamed up with Fearl Nicholls to win the mixed doubles. He failed to make a grand slam, however, as he and his partner, Whitney Warner, Jr. were defeated by Russell Grant and partner in a close, hard-fought match.

The womens singles event was most interesting as the finalists, after several torrid rounds, turned out to be two junior lassies Shirley Frye (age 14) of Akron (our candidate for National Champion in 1944) defeated Margarita Fuller (age 15) of Cincinnati. Shirley teamed with Marguerite Wright of Warren to annex the doubles title.

The Ohio Association held its annual meeting Sunday and re-elected Whitney Warner, Jr. as President and C. L. Nichols as Executive Secretary and Treasurer.

Cleveland and Cincinnati both report a tremendous increase in badminton this season, although many outstanding players are now in the service of Uncle Sam.

ST. LOUIS

The boys and girls from St. Louis really support their local association enthusiastically and whole-heartedly. We know of no other district where there is greater progress being made than there, in the "Gateway to the West." The Mid-West Association is proud to list this district as one of its most progressive members. St. Louis bids fair to become a leading center for badminton in the west.

EXHIBITION MATCHES

Do you know that you are jeopardizing your amateur standing by participating in exhibitions that have not been properly authorized???

We direct your attention to pages 10, 11 and 12 of the new rule book. Briefly, the rules are as follows:

1) Exhibition Matches-No Admission Charge

Authority required from your Class "A" Association only, subject, of course, to national rules with regard to travelling or living expenses.

2) Exhibition Matches-Admission Charge

Authority must be obtained from both your Class "A" Association and the A.B.A. Amateur Status Committee or its Regional sub-committee. The application must not only give full particulars about the proposed exhibition match, but must list the players by individual name for whom permission to participate is requested.

It is suggested that requests be made in Triplicate, 2 copies to Class "A" Association and 1 copy to Regional Tournament Committee Chairman. If satisfactory, the Class "A" Association may approve one copy and forward to the Sub Committee Chairman for his record. Upon receipt of this approval, the Sub Committee will, if found in order, issue official permit or sanction.

Inasmuch as it will require approximately 10 days to complete this procedure, you are cautioned to apply in ample time.

Review pages 10, 11 and 12 carefully with all your members, as the rules will be rigidly enforced.
