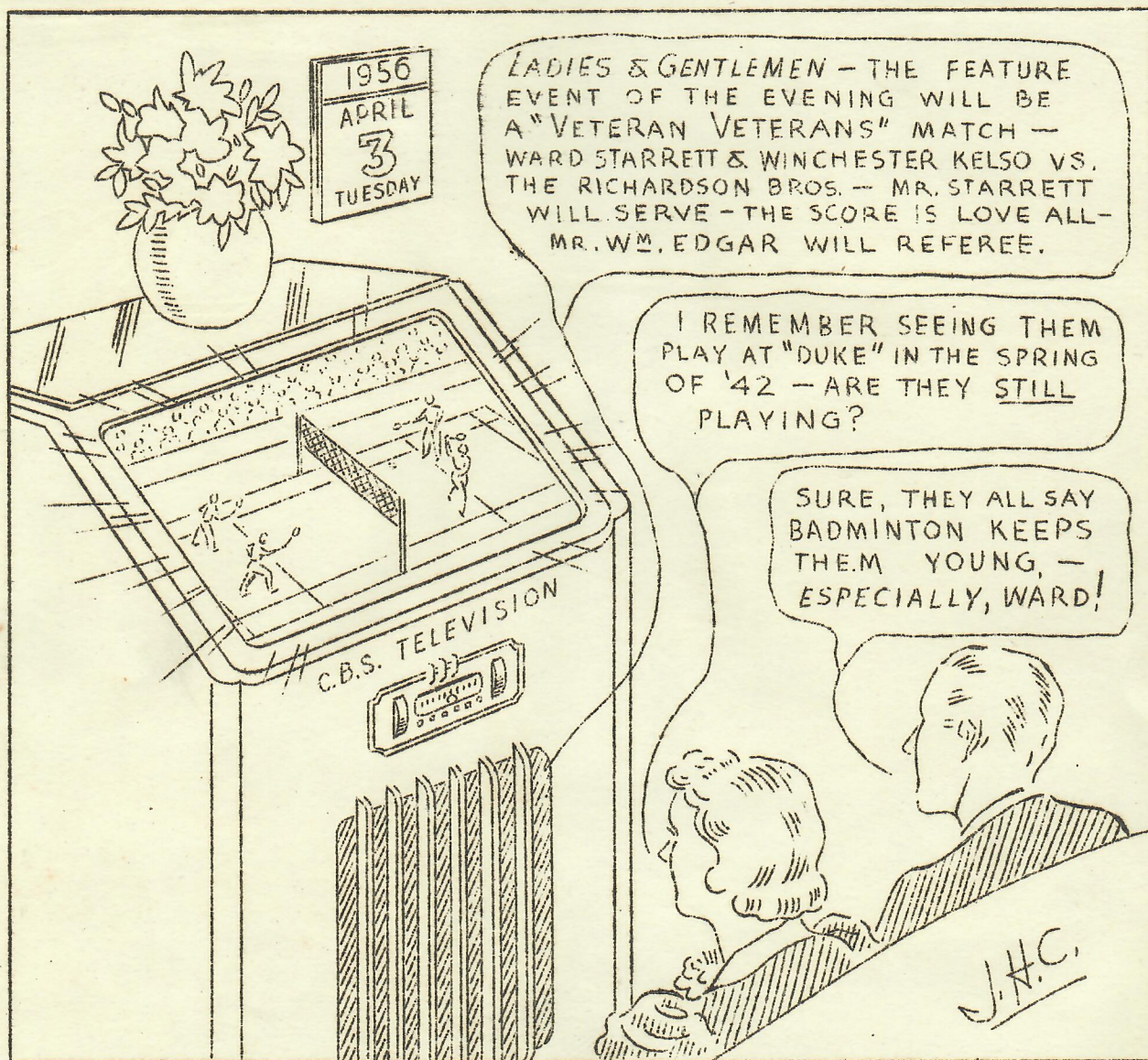

WHO SAID "IT CAN'T HAPPEN HERE"?



BADMINTON BY TELEVISION

Ten short years ago, we would have been as skeptical as the farmer who said "There ain't no sech animal" upon seeing an elephant for the first time.

In this day and age, however, we have become quite blase' and are not surprised at anything.

We are indebted to the Columbia Broadcasting System for the first presentation of Badminton via Television.

On Friday evening, October 10, 1941, the CBS Television studios, located in the Grand Central Station building at 15 Vanderbilt Avenue, New York City, presented the first evening of play in a Badminton Tournament which included the top fourteen ranking players of the East in both men's and women's divisions. This tournament was played each Friday night for one hour, and as many matches as possible were played in the time allotted.

By Friday, January 9, the tournament had reached the finals. Stig Larson of Cos Cob, Connecticut, number two ranking player in the East, faced Carl Loveday of Montclair, New Jersey, A.B.A.'s number two player.

Playing superlative Badminton and demonstrating the endurance that carried him to the number two U.S. position last year, Loveday defeated Larson 15-8, 15-7, in the best match seen on television thus far. Carl was presented with the beautiful C.B.S. silver bowl.

Friday night, January 16, Miss Betty Morse of New Haven, Connecticut, the number two ranking woman's player in the East, will play Miss Mary Hagan of the Montclair Athletic Club, Montclair, New Jersey, the number one ranking woman's player in the East, for the CBS silver bowl for women.

This uniquely presented tournament has attracted much attention in the East and has aroused more interest than any other sports program presented over television.

Bill Edgar, Chairman of the National Ranking Committee, refereed all matches.

TOURNAMENT RESULTS

Be sure to report the results of all tournaments as soon as possible, and on the official forms. If you did not receive the necessary forms with your official sanction, write to your Regional Chairman, for copies at once. One (1) copy is to be sent to your Regional Chairman and two (2) copies to the National Chairman.

This is very important as seedings and rankings are established from this information.

THE NATIONAL TOURNAMENT

Thirty days have passed since the bombing of Pearl Harbor. The first hysteria has been replaced by grim determination. A long range viewpoint has been taken by all thinking men and women.

Let us not be lulled into a false sense of security. We must arm to the teeth and be on the alert day and night.

This does not mean, however, that we should all become bundles of nerves, just one step removed from a case of "jitters." It means, rather, that we should set an example of calm strength and courage as an inspiration to those around us.

President Roosevelt has decreed that Civilian Recreation activities be increased rather than curtailed. Included in this issue is a copy of the letter, inviting Ward Starrett to participate in this program, representing Badminton. He had accepted this invitation, and plans are now being formed for an extensive and far-reaching program.

In today's mail, the writer received a copy of the December issue of "Canadian Lawn Tennis and Badminton." The editorial is devoted to a description of the plans for reinstating the Canadian Championships this year. It appears at this writing that the Canadian Association will respond to the popular demand. The Granite Club of Toronto, one of the oldest and largest, has made application for the tournament.

Canadians have found that while they lost many players to the military service during the first months

of the war, they gained as many as they lost from the ranks of the young married set. Better economic conditions, due to increased work in war industries, have made more folks financially able to afford new recreational hobbies. Hundreds of these have turned to Badminton.

There is every reason to believe that what has taken place in Canada will also obtain here.

A poll has been taken in which all directors and Class "A" Association Presidents participated.

They were asked to report on the reactions, in their area, toward the National Tournament, in the light of recent events.

The votes are not all in, but those received are unanimously in favor of no change in plans. All agreed that we should affiliate with the Red Cross or a similar war charity so that Badminton will be able to do its share.

Some of our top ranking players may be unable to compete because of Military Service; but entries will be sufficiently large and varied to guarantee an excellent contest in all events.

Transportation will be arranged with railroads, bus lines, etc. at an early date. Visitors from nearby points will undoubtedly double up and drive their own autos.



FROM OREGON

Blackout orders disrupted plans for the Annual Oregon State Mens Doubles Tournament, according to a report received from Clinton Eastman late in December. We have no further word, but presume that by now, some arrangements have been made for day+ time play on week-ends.

As an incentive to enthusiasm early in the season, the Oregon State Badminton Association sponsors monthly tournaments, using the facilities of a different member club each month. Each monthly tournament features one event only. For instance, the schedule of events of this nature for the season is as follows:

- October: Mixed Doubles Tournament
- November: Womens Doubles Tournament
- December: Mens Doubles Tournament
- January: Singles Tournament
Men and Women
- February: Husband and Wife
Mixed Doubles Tournament

Players are classified according to playing ability, thus matching players of comparable ability. Nominal entry fees, only, are charged usually enough, if possible to defray expenses; which, usually, are the costs of trophies. Member clubs donate the use of facilities, and no spectator fees are charged. Rather, outsiders are urged to attend, to create more widespread interest in the game.

Major state tournaments are held later in the season, and the results of the early season matches frequently are useful in seeding players at that time.

The current season is the second in which such events have been held. They have proved so successful that they will be continued each year.

Millard Dorntge, National Publicity Chairman writes:

"You can help your National Publicity Committee reach its objectives, which are as follows:

1. To keep and increase the interest of those who are now following our sport, either as players or spectators, and
2. To interest a substantial number of persons not now either playing or following the sport.

To accomplish these two basic objectives, the Committee recognizes that first and foremost, it must reach into every Class A Association, and with their co-operation, coordinate and synthesize the very excellent results most of these associations are getting through their local publicity channels.

To do this, we are trying to get a live member of our Committee from every Class A Association. We have been fairly successful in this, but there is still room for improvement.

The National Publicity Committee is badly in need of- and at once- a gallery of photographs, playing records and biographical material of all the players of major tournament caliber. But they are mighty slow in coming in.

Won't you, as a Badminton enthusiast, help in this- gathering what you can of this sort of data, and turning it over to your association Publicity Chairman for him to forward to us?

There is another activity you can also aid. One of the most promising fields for the extension of Badminton still open in these troubled times, is in schools, both private and public, and in the colleges.
