





IMPORTANT Changes IN ABA RULES

At the 1953 National Championships in Boston, the ABA Board of Directors took action on several argumentative issues involving important changes in our operations and rules governing the National Championships

After several years of discussion pro and con, the Championships have been opened to all amateurs affiliated through their own national organizations with the International Badminton Federation. This seems to be favored by a large proportion of the top flight American players on the grounds that it broadens competition, builds up interest in the game both among the players themselves and among the general public with the end result that they felt the popularity of our game would be increased immensely. The opponents in this matter argued that first and foremost this would no longer be a National Chamionship but it would become a World Championship similar to the All England Tournament. In this way, it would be quite likely that in some or even in all events, we might not have American champions at all.

This is an important problem because with a large foreign entry it makes the task of ranking American players almost impossible since our top players would not be playing one another and since our distances are so great that they do not have opportunity during the season to play one another either. To rank them from their showing in this tournament would not necessarily give us the answer because they are probably playing in different quarters and may never meet common foes wherein their respective showings could be determined accurately.

A second problem was what to do with the permanent trophies as it was not deemed practical to permit these trophies to be taken out of the country both from the standpoint of customs regulations throughout the world and the difficulty of having them returned at the proper time to be contested for the following year.

A third problem was that of traveling expense for champions whenever they happen to be from some nation other than the United States and what to do about expenses for the top Amer-

ican players who did not happen to be successful in winning the Championships.

In the face of these difficult problems the Board of Directors passed a resolution opening the National Championships to all I.B.F. affiliated mateur players for the next three years ending April 30, 1956. If no further official action occurs the Championships automatically revert at that time to a Closed U.S. National Championship as it has been heretofore. The President of the ABA was authorized to name a committee to make the nec-



essary rule changes to cover these and other problems involved in the opening of the tournament.

Mr. Charles Newhall, First Vice-President of the ABA was named to head a committee to revise the rules governing the National Championships and the following is an outline of these changes.

(1) The tournament shall be known as "The Open Amateur Championships of the American Badminton Association."

(2) Competition is restricted to players who are members of clubs in good standing affiliated with the ABA or with the IBF and who in every case are amateurs according to the rules of their own national association.

(3) Traveling expenses may be allowed any United States player competing in a current championship event provided he was either the winner of that same event in singles or was a member of the winning doubles team in that same event and he is re-entering with the same partner with whom he won the championship in the last preceding championship whether Open or Closed. He may also be allowed traveling expenses if in the previous championship a foreign player or team won the event and he was runner-up or was a member of the runner-up team and is again competing with the same partner. In the event that there was no United States winner or runner-up, the Executive Committee of the ABA Board may determine whether it deems it advisable and if there is sufficient money available to pay the traveling expense of a United States player or team for that particular

(4) In case a perpetual championship trophy is won by some one who is not affiliated with the ABA, this trophy shall be left in the custody of the ABA and in no case may trophies be taken outside the continental limits of the United States without the written permission of the Executive Committee which constitutes the Board of Trustees for the Perpetual Trophies.

In addition to the above matters another issue confronting the Board of Directors was that of the Seeding and Placing in the Draw of the players in the National Tournament. The policy of the ABA had never been completely spelled out in the rules with regard to the exact positions in a National Tournament Draw of players Nationally ranked from the results of the previous National Tournament and other top flight competition. The Board went on record with a resolution that the President appoint a committee to write a set of rules that would in minute detail outline the policy of recognizing Nationally ranked players by putting them in their proper positions in the National Tournament. The President appointed the recently deceased Director Irl Madden of California as Chairman of this committee and a complete set of rules was established by them and has been approved by the Directors of the ABA. Of necessity these rules also cover this problem in our present Open Championships. The main points are as follows:

(1) A Seeding and Placing Committee of the ABA shall be appointed by the President consisting of three members, all of whom should be members of the Ranking Committee unless they may be determined unavailable by the President, in which event other persons may be appointed by him. These three members shall be residents of three different re-

Dr. E. L. Burhyte, founder of the Western New York Badminton Association, will be the Honorary Chairman of the first Open National Tournament to be held at the beautiful Niagara Falls Country Club located in Lewiston, N.Y. R. Lindley Murray will serve as the Honorary Referee.

Dr. Donald Ross and Dr. Edward Dodge will be the tournament physicians. The Seeding and Placing Committee will be Ted Jarrett, Hulet Smith, and Ken Aderholt for the American Badminton Association. The local draw committee for the tournament is headed by Rex Rial. Phil Michlin is Chief Umpire.

Scoreboards for the tournament will be handled by Monte Halvargen. Monte has been with the Athletic Club as badminton-squash and tennis instructor for over twenty-eight years.

The first matches will start on four courts at the club house at 10 a.m. Wednesday, April 7, and continue until 11 p.m. Thursday schedule will be the same as Wednesday. Two courts will be used on Friday, April 9, for the third round of the Mixed Doubles and the second round of the quarter finals in all events. Play will start at 10 a.m. with time out for lunch at 12 noon. The Men's and Ladies' Singles quarter-finals matches will be played from 1:30 to 5 p.m. and the quarterfinals of the Men's and Ladies' Doubles will be played from 7:30 p.m. until 11 p.m. Only two courts will be used for the quarter-final matches in place of the three previously used by tournament committees.

The playing of the semi-finals on just one court certainly is for the pleasure of the spectator. One bracket

will be played from I p.m. to 6 p.m. and the other bracket will be from 7:30 p.m. until they are finished on Saturday, April 10th. The finals will be played from I p.m. on Sunday, April 11th.

A parking area will be reserved for players who drive to the tourney and in the spectators gallery of the club a section will be reserved for all players. Locker rooms with cots, television and cards will be provided and each player will be assigned a locker.

The golf course will be open for those of you who wish a round of golf.

Hotels and motels will be available at moderate prices. Most reservations will be made in the Hotel Niagara. Reservation blanks should be filled out carefully and mailed early to the Housing Committee.

There will be informal dancing at the club on all evenings of the tournament with cocktail parties scheduled for Friday and Saturday.

The Annual ABA meeting and luncheon will be Saturday, April 10.

Dick Harvey urges all entrants to fill the entry blanks out carefully as well as the application for spectator tickets and it is aboslutely necessary that checks for the proper amount accompany entries and applications.

New York in April

Temperatures during the day are expected to be between 50 and 80 degrees and between 35 and 50 degrees at night. Some rain is expected. The daffodils will be in bloom, trees in bud with many leaves showing and many other spring flowers will be in bloom. The grass will be green.

For Your Information

The playing floor is a natural wood. The walls are dark green and the ceiling is stained a dark brown.

Scoreboards

Scoreboards will be placed in various places for the convenience of the spectator, and following the quarter finals a filler for the program will be printed with all scores up to the semi-finals.

Food will be available at all hours with a snack bar for players and one for guests.

A repair shop will be at the club with a complete line of equipment.

—Arrangements have to be made for parking cars and policing the area. The old 14th fairway will be used as one parking area.

—Tournament plans had to be coordinated with other international events, the Canadian championships, the All Scottish tournament at Glasgow, and the All-England championships.

—The club staff has to arrange for 400-800 meals a day and cocktail parties on Thursday, Friday and Saturday nights. All meals during the week will be served buffet style.

—Chairman Dick Harvey predicts that the event will bring our club a great deal of good publicity.

Juniors At Senior Nationals

The juniors of the United States will be well represented at the Senior Tournament with the number one singles champion, Judy Devlin, of Maryland, entering. Sally Thomas of New Jersey, ranked second nationally in juniors, will be sharpening her game at Niagara and so will the number 2 junior boys, John Kevorkian of Massachusetts. Others expected are: Robert Ogilvie, New York; Linda Cobb, Massachusetts; Janet Mack, New York; Rosine Capehart, New York; Virginia Ball, Maryland; Bunky Roche, Maryland; Robert Rice, New York, and Diane Myers, California.

Places To SEE At Niagara Falls

Those of you who are coming to Niagara Falls for the first time have much to look forward to. Niagara Falls is one of the Seven Wonders of the World! What a wonderful opportunity to see some of the very best badminton in the world at our first Open National tournament and to see one of the seven wonders of the world all in the same week. There are many places for you to visit. One of the first will probably be Goat Island, lodged in the middle of the river at the brink of the Falls. From here one enjoys the view of the Upper Rapids and the river gathering momentum as it approaches the brink. A visit to the Three Sister Islands is a must before leaving Goat Island. The oldest museum in America is in Niagara Falls and worth a visit. Another must is the Falls in the evening. The night illumination of the Falls transforms the spectacle of Niagara into an almost unbelievable fantasy of color. The view from the Canada side is breathtaking.

Two miles below Niagara the Whirlpool Rapids and Great Gorge are almost as awe-inspiring as the Falls. At this point one can take an elevator from the Canada side to a promenade which affords a breathtaking view of the Rapids.

The Old Fort Niagara, located just out of Lewiston, is worth many hours of your time if you are interested in historical landmarks.

Chronological History of the Niagara Frontier

Until 1650—Occupied by Attawondaronk, or Neuter, Indians.

1650 - 1678—Occupied and controlled by Seneca Indians.

1678 - 1759—Occupied by Indians and French. Largely controlled by French.

1759 - 1796—Occupied and controlled by British.

1796 - —United States side occupied and controlled by United States.

-Canadian side occupied and controlled by Canada.

(Except for temporary shifting of sectional control by military forces during the War of 1812.)

The normal flow of water over the Falls is 25,000 tons per hour, or 222,400 cubic feet per second.

The present length of the American Falls, including Luna Island, is about 1,000 feet, height 165 feet.

gions of the Association. One shall be a resident of the region where the Championships will be held or an adjoining region.

- (2) This Committee shall be responsible for seeding and placing all players in the National Tournament. The Committee may delegate the preliminary preparation of a tentative seeding and placing of the draw to the local draw committee of the Championships subject to the National Committee approval or veto.
- (3) The seeding and placing shall be in strict accordance with the National rankings of the ABA currently in effect in so far as they apply. No singles player nor any doubles team may be seeded or placed lower than their current National rankings. Should there be a vacancy due to the failure of such player or team to enter the event then this Committee may use its best judgment in either moving up to such vacancy the next lower Nationally ranked player or team or it may place some other team or player with an outstanding season record which the Committee considers qualifies them for such position.
- (4) Foreign players shall be seeded or placed according to the best judgment of the Seeding and Placing Committee based upon the player's ranking in his own country, relative strength of his country in international play and Thomas Cup competition, and any other performance record available on the player or team.
- (5) In each event not more than one United States player or team may be seeded or placed for every 8 United States players or teams entered. Likewise, one foreign player or team may be seeded or placed for every 8 foreign players or teams entered. Also, the aggregate number of foreign seedings and placements shall not exceed those of the United States seedings and placements.
- (6) A schedule was also set up showing how the seedings and placings of players both domestic and foreign were to be placed in the draw.
- (7) The Grant System of play shall be used.

The above two projects entailed an endless amount of detail and correspondence on the part of the two committees and of course, much of the essential detail has been left out of the above brief outline for want of space. Any one interested in all of the details should contact the ABA Secretary, H. Harpel Perkins.

Just to give you an idea of the mass of detailed arrangements involved in conducting this tournament, here are some of the things that have and will be done:

—Two new doors for spectators have to be cut in the walls of the badminton courts. Only players and officials will use the present entrance to the courts and spectators' gallery.

—Publicity releases have to be distributed to 15 newspapers and radio and TV stations as well as the AP and UP wire services.

—Accommodations have to be arranged for approximately 250 visiting players.

Matches have to be scheduled over five days, using four courts for the first two days and two courts for all quarter-finals on Friday, one court for the semi-finals and finals on Saturday and Sunday.

—A 32-page program has to be edited and printed. Incidentally, members and club suppliers are urged to use this excellent advertising medium at a nominal price.



A perfect set-up for an eleven-year-old and his friends to play "cops and robbers," finally we got the idea that badminton could be as much fun as cops and robbers and of longer interest. I have been playing since and believe it's the greatest conditioner of our time. It has brought me many opportunities to travel, but above all I love the competition.

Since playing in my first tournament at the age of thirteen I have had the privilege to meet and travel with many fine people, both officials and players. Through badminton I have traveled to the United States National Championships in Los Angeles, Boston, Seattle, and Dallas. I have been to Canada, to Scotland in 1949 and to Malaya in 1952. I have played in tournaments in England, I have played in the "Happy World Stadi-um" in Singapore and "Rizal Memorial Stadium" in Manila. There is no greater thrill than to represent one's own country in a sport one loves. Being a member of the Thomas Cup Team during the past years was not only the highest honor I have received, it was the "thrill" of a life-


Badminton has given me a liberal education in geography; it has given me an opportunity to make lifetime friends in foreign countries.

I would recommend badminton to all youngsters as a sport for the future as it develops speed, coordination, quick thinking and stamina. It is a sport to be enjoyed for many many years (singles not recommended), like golf by people of all ages, it can become a family game. The great veterans team that compete in our National tourneys prove to us it is a wonderful game.

I enjoy playing badminton because the player can control the game and make it as easy or as tough as he likes—the bird can be hit back and forth or one can chase his opponent from one end of the court to the other. Either way, it is a lot of fun and it all adds up to "Badminton."

BADMINTON PERSONALITY

Our badminton personality for this issue was born in Ritzville, Washington, October 16, 1888. His badminton career began in 1933 when he started playing twice a week and sometimes four times a week. He is still playing as often, and is none other than Tim Royce, who has served badminton in various ways.

On April 30, 1911, he married Ola Butler of Spokane. In the fall of 1912 they moved to Seattle where they have lived since. They have two children, a son Robert, and a daughter, Mrs. Jess Rounds, and four grand-children, Peggy Royce 9, Susy Royce 7, Harriet Rounds 12, and Tim Rounds 10, all living in Seattle. Tim writes that he is having some success in encouraging the grandchildren to play his favorite game.

In 1940 he teamed with George McCook, of Pasadena, to win the National Championship Veterans' Doubles event. In the January, 1943, issue of "Bird Chatter" the correspondent wrote, "We note, from our score sheet, that our "star-reporter," Tim Royce, succumbed in the first round of singles after a tough three game match. He bounced right back in the mixed, though, and was in there pitching up to the quarters."

Tim has written articles off and on for B.C. since 1942. During that year the Seattle Invitational Handicap Tournament charged 75¢ per person with shuttles and trophies supplied.

In 1946 he served as vice-president



of the ABA and as director of Region Six. He served on the Amateur Status Committee and the Constitutional Revision Committee during 1946-47. Tim was mentioned in Bird Chatter that year as one of Seattle's great badminton stars.

Tim served as president of the ABA from April, 1948 to April, 1950.

He has served on the Thomas Cup Committee and is chairman of the Handbook Committee. He served as executive secretary of Bird Chatter for one year and was honorary chairman of the 12th Annual United States National Tournament held in Seattle.

His hobbies besides badminton are history, biography and geography.

Tim is a very successful lawyer in Seattle and is in general practice with his son at 3002 Smith Tower. In his letter to your editor, Tim placed the following after the last sentence (advt.), which shows he is on his toes.

The publication of "Eminent Judges and Lawyers of the Northwest," being published in Palo Alto, has been asking Tim for a biography (not written for lack of material according to Tim). Photographers took pictures three months ago and our personality refused to buy either pictures or the book and, says Tim, "They still want it—the biography, that is.'

Tim belongs to two clubs, more or less, the Oueen Anne and the Racqueteers. George Pratt, a newspaper reporter, once said, "Mrs. Royce does not play badminton but she is not a badminton widow either, she is the best spectator the game has."

Following are Tim's own words in explanation of the "T.M." "Even when I was admitted to the bar of the Supreme Court of the United States, they were satisfied with the initials 'T.M.' Never questioned about them. I really think they were more interested in the \$25.00 admission fee than anything else." (We are much more curious than the U.S.—T.M. stands for Thompson Morton.)

The server and the player served must stand within the limits of their respective service-courts (as bounded by the short and the long service, the central, and side lines), and some part of both feet of these players must remain in contact with the ground in a stationary position until the service is delivered. A foot on or touching a line in the case of either the server or the receiver shall be held to be outside his service-court, Law 14 (c). The respective partners may take up any position, provided they do not unsight or otherwise obstruct an opponent.

If a player has a chance of striking the shuttle in a downward direction when near the net, his opponent must not put up his racket near the net on the chance of the shuttle rebounding from it. This is obstruction within the meaning of Law 14 (j). A player may, however, hold up his racket to protect his face from being hit if he does not thereby balk an opponent.

NATIONAL and INTERNATIONAL HIGHLIGHTS

by Ken Davidson Chairman, Overseas Players Committee

Not Two, but Four, Malayans Are Coming

Eddy and David Choong, the Malayan brothers studying in London, are planning to play in the U.S.A. National Championships at the Niagara Falls Country Club, N.Y., on April 7-11. In addition, the Badminton Association of Malaya has cabled entries in the Men's Singles, and as a Men's Doubles team, for Ooi Teik Hock, the great hero of Malaya's Thomas Cup matches of 1949, and Ong Poh Lim, that loose-jointed, unorthodox but highly effective bundle of perpetual motion.

The entry of these four Malayans presents a tremendous challenge to our American players. It would be impossible to choose four better all around visitors to enter our first open

National Championships. Any one of these four Malayan boys of Chinese extraction would prove an attraction, but with four of them coming over the spectators are assured of many

exciting and thrilling contests.

Strong as the Malayans are, they can be beaten, as instanced by Bob Williams and Wynn Rogers beating Malaya's champions, Chan Kon Leong and A. Piruz, in the 1952 Thomas Cup matches in Singapore, and Marten Mendez's victory over Ooi Teik Hock in Singles during the same Tie. But our American boys must be at their best because all these Malayans enter wholeheartedly and fervently into their matches, particularly when they are representing their country.

Although the Choongs have not represented Malaya in International matches, simply because they were studying in Britain at the time of the 1952 Thomas Cup competition, many suspect they are the strongest Men's Doubles pair in the world today. David, present holder, with Miss June White, the All-England Mixed Doubles title, is undoubtedly a sound doubles player of the highest standard. He has a particularly effective smash.

Eddy, the younger brother, is the present All-England Singles champion and is confident that he will successfully defend this title in March prior to his flying over here. However, al-

though he has been carrying off dozens of Singles trophies throughout Europe, he will run into tougher opposition at Niagara Falls. He can expect challenges from Ooi Teik Hock, a quiet-spoken, brainy player who rarely plays the wrong shot and who is a tremendous fighter of the Dick Mitchell type-won't give up till the last point is scored—who, on two occasions, took games from the unbeaten Dave Freeman in 1949; and from Ong Poh Lim, whose whirlwind methods upset the best and create much amusement with the crowd. Then, too, Don Smythe, Canadian Champion, who is an unexpected entrant, split wins with Eddy during the January tour of Canada by the Choong brothers, beating Eddy in three games at Montreal, and losing in two games in the finals of the Strathgowan Tournament in Toronto. Since both Joe Alston and Marten Mendez own wins over Don Smythe, it doesn't need too much imagination to see the intriguing possibilities of such a power-packed entry as will be at Niagara Falls.

With all the great matches already in prospect, the stands should be packed to over-flowing at each session of the five-day tournament. But it is hoped that, before the March 17 dead-line for entries, other Internationalists from countries such as Sweden, Denmark, India, Mexico and Great Britain will add further color and interest to this, the first open U.S.A. Nationals.

While emphasis so far has been on the men, because of the four Malayans already entered, there is no thought of overlooking the ladies. At the moment, there has been no indication that there will be any female entry from overseas but it is expected that there will be a strong entry from our friendly rivals north of the border, Canada, who gave evidence at the Strathgowan Tournament that they present a strong challenge to our United States girls, particularly in doubles. Such United States representatives as Judy Devlin, Margaret Varner, Thelma Scovil Welcome, Lois Alston, Abbie Rutledge, Sue Devlin,

Janet Wright, Beulah Bymaster, Loma Smith, Dottie Hann, Helen Gibson, Ethel Marshall and Bea Massman will meet this challenge.

Although more mention has been made of outside-the-border players, simply to bring their records to the notice of "Bird Chatter" readers, it is hoped and expected that there will be a large entry of United States players from all parts of the country, drawn to Niagara Falls to see all the newcomers to our shores and to help repel the onslaught on our National titles expected from the visitors. Naturally, our hopes of success will be with our home players, but all our visitors can be assured that they will be welcome guests and will receive applause and encouragement equal to the degree of their skill and efforts on the court.

Americans Dominate Canadian District Jr. Badminton Tourney

Bea Massman, Correspondent The Niagara Falls Tennis & Badminton Club in Niagara Falls, Ontario, held its first annual Niagara District Open Junior Badminton Tournament Saturday, Dec. 19th. 

NEW ABA SANCTION FEES ANNOUNCED

Sanction fees are now as follows: \$1.00 for club, city or junior tournaments; \$5.00 for invitational, district, open and all other tournaments.

All tournaments run by clubs belonging to the Midwest or the A.B.A. must be sanctioned by the A.B.A. This is a minor source of income for the A.B.A., and serves one very important purpose for the club running the tournament; that is, if the date chosen by the club coincides with another tournament in the same region, the club is so advised upon receipt of its application for sanction, and is thus spared the problem of competing for players with a nearby tournament. The procedure for obtaining a sanction is to file an application to the undersigned, on forms furnished by him.
